5. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

A. REVIEW AND RELEASE FOR 30 DAY PUBLIC REVIEW OF THE DRAFT FFY 2018-2023 MPO TRANSPORTATION IMPROVEMENT PROGRAM

Mr. Wilson said at the last TCC meeting we went through the list of projects that were submitted for consideration as part of this TIP. He noted that he met with Steve Lopez of District 5 and Rebecca Maes last Monday to go through the list. The Farmington MPO also participated in the meeting to see what funding could be identified for the projects in the priority list. No funds were identified.

Mr. Wilson reviewed the handout that was included in the packet.

Mr. Wilson said the feedback they got from the District was that after the Reprioritization Study is completed they will program funds for whatever the top priority is for 2024. The 1-25/La Cienega Interchange was not discussed because they did not have any communications on how this would be programmed. For the Northeast Connector project they suggested that the best route for the County to take could be once the Highway Safety Improvement Program funding frees up they would have the County do a new application for their route safety audit and get in the pipeline for funding through that mechanism. That funding is expected to be freed up soon.

Mr. Wilson said for the Avenida del Sur Extension, DOT suggested that the County try and fund at least Phase A and B of a location study to line it up for future potential funding for design and construction. For the Rancho Viejo bike lanes, they suggested that they look to apply for Transportation TARIFF funding when that opens up in a couple of years.

Mr. Wilson said essentially the draft TIP, with one exception, includes all the projects that are currently programmed in the 2016 through 2021 TIP. The one communication he got on Friday was the District informed him that for S100440 and a TIP Amendment, they are bumping this up to \$10,500,000. Now, due to fiscal constraints, they need to bring that back down to \$5.8 million. He is still waiting for clarification on that. All the projects that are proposed in the FFY2018 through FFY2023 TIP are the projects listed in the 2016-2021 TIP, other than the Transit Rail project. There are two new projects that will be added and they are non-motorized projects. One is for the Santa Fe Rail Trail Segment 6 coming out of the southern end of Eldorado and a section of the Arroyo Hondo Trail in the Community College District.

Mr. Wilson said this is what the FFY2018 - 2023 TIP looks like. We need to go out for a 30 day public review, close it on June 17th or 18th, come back to the TCC on

June 19th for your review, comments, and recommendation and finalize the TIP by June 30th for DOT. A public hearing is required and we are proposing to hold that meeting on Tuesday, June 6, from 5:00 pm to 6:30 pm. At this point we are looking for permission to release the document for the 30 day public review.

Mr. Quintana asked if the Farmington MPO had any projects to do.

Mr. Brasher said Farmington has three bridge replacement projects in process right now. He noted that the costs were brought down to \$5.2 million from the original number of \$8.5 million.

Mr. Quintana asked regarding the NE Connector project, are they talking about Rabbit Road improvements specifically.

Mr. Wilson said yes, that is correct.

Chair Romero asked if any safety funds were freed up in 2019 because they moved the Rail Trail underpass to 2020.

Mr. Wilson said he did not know.

Chair Romero said if it did free up safety funds they have a place to spent those - the Agua Fria/Cottonwood Drive intersection. The alternative that was selected was a little more expensive than what was anticipated in the scope.

Mr. Wilson said he was told that they are looking at the budget to see if it is available.

Mr. Brasher asked how much more is the Agua Fria/Cottonwood Drive intersection going to cost.

Chair Romero said it depends on the scope but it could go up \$500,000 because they are not being told that they may have to put in some lighting which was not anticipated in the original scope.

Mr. Quintana added that they want to do some construction management as well.

Mr. Wilson said they should know more of a defined number in the next cycle. This is a starting point and they could add to this list in the future.

MOTION A motion was made by Mr. Quintana, seconded by Mr. Brasher, to release the Draft FFY2018 - 2023 MPO Transportation Improvement Program for a 30 day public review.

VOTE The motion passed unanimously by voice vote.

6. MATTERS FROM MPO STAFF

Mr. Tibbetts said this is Bike to Work Week.

7. MATTERS FROM TCC MEMBERS

Mr. Gomez asked how difficult is it to change or modify a project once it has been submitted. The NE Location Study has been a big deal with the DOT because the NE Connector for project number 1 says the NE Connector for the I-25 Frontage Road from Richards to St. Francis Drive has to be done. This has created a lot of problems because the Study did not go all the way to St. Francis and now they have to do a lot of additional things.

Mr. Wilson said it is tied to what the terminology is in the TIP and the terminology is St. Francis Drive to Richards. They cannot go back and change a TIP. To change it would require a change in what the document says. He asked Mr. Gomez to send him an email about this and he will pursue it with the State Coordinator.

Mr. Gomez said they are working with the District to try to resolve this.

Mr. Wilson said an amendment would have to be done if the funding changes by 20%. We have to do an amendment to that project anyway based on what comes out from the MOU amendment and funding.

Chair Romero asked when will the Road Safety Audits applications be solicited.

Mr. Wilson said he did not think there was a time line presently.

Chair Romero asked if the practice now is that you have to ask for an RSA first to be eligible for construction funding.

Mr. Aune said he believes that is the intent as it is drafted now.

Chair Romero asked if they are holding off on performing RSAs or holding off on everything.

Mr. Wilson said he heard that the DOT was not submitting any new applications because they are working on the backlog they have.

Mr. MacPherson said over five years, the St. Michaels Drive Corridor improvements will be over \$16 million. He asked what is this money going to be used for.

Mr. Wilson said part of the money is for the Rail Trail underpass and another part

of the money is for re-paving and making ADA improvements. The bulk of the money is for the St. Michaels Drive Interchange improvements. They also include a road study in the scope.

Mr. Brasher said the RFP will go out in the Summer of 2018.

Mr. Wilson asked if the DOT will be the lead agency.

Mr. Brasher said yes.

RE-RELEASE OF THE PROPOSED DRAFT AMENDMENT 6 TO THE TRANSPORTATION IMPROVEMENT PROGRAM Federal Fiscal Years 2016–2021

PUBLIC COMMENT PERIOD: 06/01/17 – 06/15/17 TCC Review and Recommendation: 06/19/17 TPB Public Hearing and Action: 06/19/17

After the close of the original Public Comment Period that ran from 05/03 to 05/17, NMDOT requested additional changes to S100440 to bring the STIP into fiscal constraints. It was determined that these changes were significant enough to re-release the amendment for a new 15-day public review.

The new Public Comment Period is running from June 1, 2017 through June 15, 2017. Those who submitted public comment during the first comment period were notified that their original submitted comments would be included for review for the second public comment period, but they were also welcome to submit new or additional public comments. Through June 12, the public comment from David McQuarie and Aurore Black was resubmitted, but no new comments have been submitted. The Public Comments received have been attached with this packet. If additional public comments from now until June 15 are submitted they will be submitted for review.

PROPOSED CHANGES TO EXISTING PROJECTS

<u>S100230 – NM14 (Cerrillos Rd) ADA Feasibility Study and ROW Acquisition. MM53 (St Michaels Drive) to MM56 (St Francis Drive) [NMDOT Lead]</u>

Justification:

This project is requested to be deleted from the STIP and TIP because the NMDOT does not anticipate the completion of a Road Transfer agreement between the City of Santa Fe and the NMDOT within the timeline of the current NMDOT STIP. The design and construction funding previously identified for this project is needed for the design and construction of District 5 projects needing funding in the FY 2018 and 2019 STIP years

<u>S100440 – St Michaels Drive Corridor Improvements [NMDOT Lead]</u>

- Move Rail Trail Underpass Design Funding (\$285,000) from FFY2017 to FFY2019
- Move Rail Trail Underpass Construction project and FFY2019 funding (\$2,850,000) from S100470.

Dear Mr. Tibbetts:

A Road Transfer Agreement for NM14/Cerillos Road between the City of Santa Fe and the New Mexico Department of Transportation hasn't happened in over a decade and **may never happen**. It is currently not anticipated in at least the next four years. This lack of a "Road Transfer Agreement" is not an excuse for the NMDOT to delay once again making the bus stop in front of the Indian Hospital at Cerillos Road and Second Street accessible.

NMDOT has actually admitted that they have the responsibility to meet ADA standards at the bus stop in front of the Indian Hospital in advance of the Road Transfer but lack funding for the project. Whatever other projects are needed in District 5 over the next two years, by law, this project must be given priority. If current District 5 funding is not adequate, the State of New Mexico must find the money out of reserves or other emergency funding.

We are writing this letter as citizens of Santa Fe. You will see from the enclosures how unresponsive the NMDOT has been to this accessibility problem in front of a medical facility and a school that serve members from minority populations and

persons with limited resources. To prove Title 1, 2, and 6 violations of U.S. law, one only has to put pictures of the bus stops from different facilities side by side.

Plans to make the intersection at Cerillos Road and Second Street accessible are partially (30-60%) drawn [Santa Fe County SP-5-16(385) CN M500887] because a start date of July 2017 was promised last year (see 2016 enclosures) and a cost estimate has been made. To save costs, only the two south corners of the intersection need to be made accessible. The two corners on the north would be curb cuts to nowhere because there are no passable sidewalks there anyway. A pull-in/pull-out bus stop as requested by the City of Santa Fe also seems unnecessary if that requirement prevents a timely remedy that will work for persons using wheelchairs and scooters.

We are not the only two people in Santa Fe who care about people who use wheelchairs and scooters and might need medical care. By copy of this letter, the FHWA is hereby notified of our stance on this issue. The Mayor's Committee on Disability and the Transit Advisory Board are also monitoring this breach of responsibility by the NMDOT.

There can be no more excuses on this project to provide accessibility as required under the ADA. The Road-Transfer-Agreement excuse expired several years ago with the repeated (and now continued) postponements of the transfer plans. NMDOT has agreed that they MUST fix this intersection. There are no excuses that justify further delay. This project needs to be fixed this summer, and we as citizens will call upon fellow citizens, friends and media contacts to help keep the NMDOT accountable for a timely remedy.

I appreciate your offer to forward the following to NMDOT District 5. The central issue is the restricted pedestrian access at Cerrillos Rd. (NM 14) / Second St. Indian / Hospital (PHS) entrance.

Some comments relative to this intersection are:

- Cerrillos Rd. (NM 14) is a divided 4-lane facility running north and south. Second St. is 2-lane on the east leg. The Indian Hospital entrance is 2-lane on the west leg.
- This intersection is fully signalized including "ped head."
- Site of pedestrian fatality. Pedestrian was female, American Indian and disabled (hearing, I believe).
- This intersection was included in the 2006 Pavement Rehabilitation plan review by the Mayor's Committee on Disability. The report recommended that Engineering assess actual need and negotiate with the Indians (BIA). Other than pavement overlay on Second St., no improvements are in evidence.
- Periodically the inaccessibility at this location has been included in various written correspondence to the City.
- On both the SW and NW quadrants curbs restrict access to signal controls and ped crossings of both roadways.

I have received a written request for "Reasonable Accommodation" from Mr. Dave McQuarie. (See Attached) Mr. McQuarie is requesting to have curb cuts and curb ramps installed at the intersection of Cerrillos Rd. and Second St. so as to allow access to pedestrians, including person's with disabilities.

The Americans with Disabilities Act Accessibility Guidelines (ADAAG) 10.2.2 (1) states "Bus stop sites shall be chosen such that, to the maximum extent practicable, the areas where lifts or ramps are to be deployed comply with section 10.2.1 (1) and (2). ADAAG 10.1.1 (1) states; "Where new bus stop pads are constructed at bus stops, bays or other areas where a lift or ramp is to be deployed, they shall have a firm, stable surface; a minimum clear length of 96 inches (measured from the curb or vehicle roadway edge) and a minimum clear width of 60 inches (measured parallel to the vehicle roadway) to them maximum extent allowed by legal or site constraints; and shall be connected to streets, sidewalks or pedestrian paths by an accessible route complying with 4.3.2 (1) At least one accessible route within the boundary of the site shall be provided from public transportation stops, accessible parking and accessible passenger loading zones, public streets or sidewalks to the accessible building entrances they serve.

Mr. McQuarie states he has made numerous attempts to correct this concern with the City of Santa Fe, but has had no success. Currently Cerrillos Rd. is owned and maintained by the New Mexico Department of Transportation, District Five Patrol, so the district has a responsibility to provide this accommodation to allow pedestrians, including those with disabilities, access to the sidewalk or established dirt path, which would include access to the Bus Stop.



Thank you for attending the February 22nd Transit Advisory Board (TAB) meeting and for your comments regarding your past efforts with the City of Santa Fe and the New Mexico Department of Transportation (NMDOT) to create access to the bus stop at the intersection of Cerrillos Road and Second Street (in front of the Santa Fe Indian Hospital) for persons with disabilities.

The Office of Equal Opportunity Programs (OEOP) would like to thank you for your latest inquiry into the ADA facilities at 2nd St. and Cerrillos Road. Our office has consulted with District 5 staff, including District Engineer Miguel Galbadon to work through possible solutions to bring this intersection into ADA compliance.

NMDOT District 5 will move forward with efforts to remedy the specific intersection at 2nd Street and Cerrillos. That site-specific work is intended to, among other things, provide access for persons with disabilities from the city's transit stops near the intersection to the property containing the Indian medical facilities. The NMDOT has completed the preliminary design work and will continue these efforts with the possibility of a project being constructed during the summer of 2015. This timeline is dependent upon right-of-way acquisition and environmental clearances at the intersection for the proposed improvements.

The long term improvements for the remaining Cerrillos Road corridor between St. Michael's and St. Francis Dr. could occur in 2020 or 2021. This would include a study of the remaining corridor followed by design and construction along that corridor. This is a major initiative with significant utility issues, environmental issues and right-of-way acquisition issues.

Last year, you brought all the parties together to get the bus stop fixed at Second Street and Cerillos Road in front of the Indian Hospital, with a planned start date of July 2017.

Last night at the Transit Advisory Board, Transit staff said that the project is now to fix the entire intersection in terms of accessibility. It's admirable that the DOT wants to fix the whole thing, but the price tag is \$2.5 million, and now they are not going to do it at all because they don't have that much money. Putting in just the new bus stop on the outbound side is less than \$150,000, but the DOT is saying that the city should pay for that even though the road is still a state highway.

Please excuse the high level of frustration that the local disability community is expressing regarding this matter, but this is, in our opinion, why this inaccessible site (which is in violation of ADA law) does not get fixed. The state wants to fix the whole section/intersection, and then does nothing because the whole task is too expensive or overwhelming. Please help in moving this crucial ADA site improvement project forward. Your support for the disabled community's basic human rights is very much appreciated. We need your assistance to ensure that this site gets improved and is ADA accessible.

PROPOSED DRAFT OF THE FEDERAL FISCAL YEAR 2018-2023 TRANSPORTATION IMPROVEMENT PROGRAM

PUBLIC COMMENT PERIOD: 05/17/17 – 06/15/17 TCC Review and Recommendation: 06/19/17 TPB Public Hearing and Action: 06/19/17

Every two years the Santa Fe MPO under takes a process to develop a new 6 year Transportation Improvement Program. During this process to years drop out of the TIP and two new years are added. The process for developing a new TIP is outlined in the MPO's <u>Public Participation Plan</u>. The current process is developing the Federal Fiscal Year (FFY) 2018-2023 Transportation Improvement Program (TIP) within the MPO Planning Area.

A Call for Projects for National Highway Performance Program (NHPP) and Surface Transportation Block Grant Program (STBG) funding was issued in January to the MPO Member Agencies. This Call for Projects **did not** include applications for funding under the Highway Safety Improvement Program (HSIP), Transportation Alternatives Program (TAP), Recreational Trails Program (RTP), and Congestion Management Air Quality (CMAQ) Program as these funds are awarded under separate processes.

Eligible projects had to be included in, or consistent with the <u>Metropolitan Transportation Plan</u> 2015-2040.

MPO Staff reviewed the eligibility of submitted projects and created an initial ranking using the Regional Roadway Project Evaluation Criteria outlined in Chapter 7 of the Metropolitan Transportation Plan. The list of projects was then presented to the MPO Technical Coordinating Committee (TCC) for discussion and approval at their April 24th. The list of submitted projects is attached.

MPO Staff then worked in consultation with NMDOT District 5 and the STIP Coordinator to review the needs of the whole District in determining the level of funding that would be available for projects in the Santa Fe MPO TIP. Out of this consultation it was determined that the only project to receive funding through this process would be S100440 (St Michaels Drive Corridor Improvements) in the amount of \$5,500,000 in FFY2022. For the unfunded projects in the prioritized list NMDOT suggested potential alternative funding sources could be applied for:

- NM599/Via Veteranos Interchange NMDOT indicated that once the NM599
 Interchange Reprioritization Study currently in process is completed that they would look to program funding for the top priority in FFY2024
- North-East Connector (Rabbit Road) Improvements NMDOT indicated that this project
 may be eligible to apply for Highway Safety Improvement Funding (HSIP) with the next
 application process (No schedule for the application process has been set)
- Avenida Del Sur Extension NMDOT suggested that Santa Fe County consider funding the Location Study for this roadway, which would make them eligible to apply for federal funding in the future.

• Rancho Viejo Boulevard Bike Lanes – NMDOT suggested that Santa Fe County apply for Transportation Alternatives Program (TAP) funding for this project. (Next application process will likely happen in 2018 or 2019 for FFY2021 and 2022 Funding).

New Projects/Funding added to the TIP

Santa Fe County has been awarded FFY2018 Transportation Alternative Program funding for 2 Trail projects that have been included in this draft.

Additionally, formula transit funding has been added for FFY2022 and 2023. These funding amounts are included as placeholders and will be adjusted once actual funding amounts are released.

Public Review Process

The draft FFY2018-2023 TIP was presented to the TCC on May 15th where they approved the release for a 30-day Public Review.

The proposed draft of the FFY2018-2023 Transportation Improvement Program that was released for public review is attached

The Public Comment Period runs from May 7, 2017 through June 15, 2017.

A Public Input Meeting as required by our Public Participation Plan was held on Wednesday June 7 from 4:00PM to 6:00PM at the City of Santa Fe Offices @ Market Station, 500 Market Street, Suite 200. One person attended the Public Input Meeting and asked questions about several of the projects included in the TIP but did not provide any written or verbal comments on the document.

As of June 12, no public comment has been submitted. If public comment is submitted from now until the end of the public comment period on June 15 it will be provided for review.

The Technical Coordinating Committee will review any submitted public comment and make a recommendation to the Policy Board at their meeting on June 19.

The Policy Board will hold a Public Hearing before taking action on the FFY2018-2023 TIP before taking action at their meeting on June 19.

The FFY2018-2023 TIP does not take effect until October 1, 2017.

- Mr. Matthews said we would like to withdraw the project entitled Richards Avenue Bike Lanes. It is in our draft infrastructure study. The design will include off road bike lanes. We ask to withdraw the project.
- Mr. Wilson said Los Suenos Trail is probably not eligible for funding this year. He recommends not carrying it forward at this time.
 - Mr. Matthews said we can bring that back to management.
- Mr. Wilson said the next step is to sit down with the District and the STIP Coordinator to discuss funding possibilities. Then we will develop a proposed draft TIP. It will then go out for a 30 day public review and then back to this Committee. We would like your concurrence now with the prioritization as presented.
- Mr. Aaboe said on the bottom table, S100230, you have amendment amounts but it is deleted in the list.
- Mr. Wilson said they are going out for public review and modification in May. That will be reflected in the draft.
- Mr. Brasher said he disagrees with the priority funding that puts the interchange at the top of the list. That assumes that the results of the study will show it as a priority.
- Mr. Wilson said he can put an astrerick on the item that says it's priority is pending the outcome of the study.
- Mr. Brasher said he would have put NE connector first. The study will be complete in November. We are gathering information at this time.

Chair Romero said these numbers are part of an already approved plan. We are tasked with going with our current plan. It scored first. It went through a well vetted process. This is a representation of what this Committee feels are the priorities of the region. He does not see that the corridor study would change that, other than the high amount of crashes which would indicate the high priority.

There was further discussion on this

It was decided that the asterisk and note as described previously would be added to the priority list.

MOTION

A motion was made by Mr. Brasher, seconded by Mr. Quintana, to concurwith the prioritization list with the asterisk and note included and with the removal of the I-25/La Cienega project, the Los Suenos Trail project and the Richards Avenue Bike Lanes project.

The motion passed unanimously by voice vote.

C. UPDATED NEW MEXICO POPULATION PROJECTIONS FROM UNM GPS

Mr. Tibbetts introduced Kendra Montanari, Mid Region of the Council of Governments, who will give a presentation on the population projections from the UNM GPS.

Ms. Montanari handed out a copy of her presentation which is incorporated herewith into these minutes as Exhibit "5". She proceeded with her presentation.

QUESTIONS FROM THE COMMITTEE WERE AS FOLLOWS:

- Mr. Mortillaro asked regarding the migration shown for Santa Fe County, do you know what age group is causing that migration.
- Ms. Montanari said we looked at the State as a whole. It was young working professionals ages 20 to 35.
 - Mr. Brasher asked you said they use the census as a benchmark.
 - Ms. Montanari said yes, and estimates every year between the census.
 - Mr. Brasher asked how much further broken down are these numbers.
- Ms. Montanari said it is simple data from the census. It can be as detailed as you want.

Mr. Brasher asked do the projections have how many vehicles are owned and other vehicle information.

Ms. Montanari said no, the is data by age, race and gender.

Chair Romero thanked Ms. Montanari for her presentation and information.

D. UPDATE ON TRANSPORTATION IMPROVEMENT PROGRAM PROJECTS

Mr. Wilson handed out the update on the Transportation Improvement Program Projects which is incorporated herewith as Exhibit "6". He said he will send out the list for updates and we will go over them at the next meeting.

7. MATTERS FROM MPO STAFF

Mr. Tibbetts said the Zia Station finally opened today. He wants to acknowledge Mr. Wilson as he has spent the last 3 years facilitating this.

Mr. Wilson said it has been 7 years.

Chair Romero thanked Mr. Wilson.

Mr. Tibbetts said the train first came to Santa Fe in December of 2008 and the TCC recommended that Zia station be opened. It sat until 2010 before anything happened. Then Keith and the MPO asked to help get it open. Now it is done. It remains to be seen how many people will actually use that station.

Mr. Wilson said it was one step forward and 2 steps back for a lot of it. Please call him if anyone sees any issues. He has to report back to Council in 6 months.
