## EARLY NEIGHBORHOOD NOTIFICATION MEETING

August 26, 2020

Dear Neighbor:

The City of Santa Fe is designing improvements at the intersection of Sandoval Street and Montezuma Avenue to improve traffic flow and pedestrian and bicycle safety. This new roadway project is being designed by Wilson & Company – an engineering design firm hired by the City's Public Works.

The City of Santa Fe requires an Early Neighborhood Notification (ENN) meeting be conducted for city's capital infrastructure projects. It is intended to provide opportunity for the community to review, comment, and provide significant feedback on city's capital infrastructure projects before plans become too firm to respond meaningfully to community's concerns.

• By phone: A person attending the GoToMeeting by phone may provide public comment during the meeting but must provide advance notice to Tyler Ashton, Civil Engineer (505-348-4121), Tyler.Ashton@wilsonco.com no later than Friday, September 11, 2020, and provide your full name, address, and the phone number you will be using to call in to the teleconference. Without your phone number, the meeting facilitator will not be able to recognize you to speak at the meeting.

• In writing: A person may submit written public comments in advance of the meeting by email (Tyler.Ashton@wilsonco.com), or by U.S. Postal Service (Wilson & Company, ATTN: Tyler Ashton, Civil Engineer, 4401 Masthead Street NE, Suite 150, Albuquerque, NM 87109). Please include your full name and address. To be included in the official record and considered at the meeting, written public comment must be received no later than Friday, September 4, 2020.




Attachments: Vicinity map Site plan
