**Esther Coker.** Ms. Coker spoke to her concern about the ski traffic and the need to have practical and sensible solutions for that issue.

Mr. Brasher joined the meeting.

**6. DISCUSSION ITEMS**

**A. SELECTION OF TPB CHAIR AND VICE CHAIR**

**MOTION** A motion was made by Commissioner Hansen, seconded by Councilor Castro, to elect Commissioner Greene as Chairman of the Board.

**VOTE** The motion passed on a voice vote.

**MOTION** A motion was made by Commissioner Hansen, seconded by Councilor Faulkner, to elect Councilor Castro as Vice Chair of the Board.

**VOTE** The motion passed on a voice vote.

**B. REVIEW AND RECOMMEND: 2024-2029 FORMAL TIP AMENDMENT 2 VIA SELF-CERTIFICATE**

Mr. Aune gave an overview of what the TIP is and reviewed the amendment.

Commissioner Hughes asked if the amendment included the 1-25/Old Pecos Trail entrance.

Mr. Aune said no, it does not include that.

**MOTION** A motion was made by Commissioner Hansen, seconded by Commissioner Hughes, to approve the 2024-2029 Formal TIP Amendment 2 via self-certificate

**VOTE** The motion passed on a voice vote.

**C. REVIEW AND RECOMMEND: ADOPTION OF PERFORMANCE MEASURES 1: SAFETY TARGETS VIA SELF-CERTIFICATE**

Mr. Aune gave an overview of the safety measures, the analysis done by NMDOT, trends and the data.

Chair Greene asked, "what can we do to help with the data points so we can localize the information."

Mr. Aune said he will bring that discussion to Hannah, and we can do a memo to all of you regarding what we can do, with your help, to design something more sophisticated.

Chair Greene asked Mr. Brasher if he has any insight since DOT is responsible for the information we are looking at.

Mr. Brasher said it is disturbing that the fatalities are increasing and the serious injuries are decreasing on the graph. There are so many more miles being driven.

Mr. Aune said DOT contracts with UNM to analyze the raw data.

Mr. Brasher said the data comes from police reports.

Chair Greene said he thinks the State has data on pedestrian and other non-motorized road users.

Mr. Aune said the data you are looking at includes targets that are Federally set. We have data that separates out pedestrians and other categories and includes factors surrounding the crashes.

Mr. Brasher said there is a category called Vulnerable Road Users. That includes bicyclists, pedestrians, disabled road users and other non-motorized users. That is a separate data set.

There was a discussion around the formation of targets.

Chair Greene said it is up to us to work on projects to improve those numbers.

**MOTION** A motion was made by Commissioner Hughes, seconded by Commissioner Hansen, to adopt the safety measures via self-certificate.

**VOTE** The motion passed on a voice vote.

## **D. OVERVIEW OF MPO TRAINING MANUAL**

Mr. Aune said he sent the MPO Training Manual to all of the Board members. It is a Federal requirement that we share the Manual with all of you. If you have any questions, please contact us.

Councilor Faulkner said she is legally blind. Transportation is critical for the disabled community. She is excited to dive into that.

Mr. Brasher said he is the District Engineer for District 4, and the acting District 3 Engineer. He appreciates all the work Eric and his staff do and all of the effort they put into this.

Chair Greene said he would like an update on Hyde Park Road at the next meeting.

Mr. Brasher said he will be prepared to give a report.

Chair Greene stated that he has heard from constituents regarding their concerns about traffic and speeding at the entrance to Santa Fe near Alamo Street and on Hyde Park Road coming down the hill. He suggested some traffic calming be considered in those areas.

Mr. Aune said he will get with Javier and put a memo together on these issues for Chair Greene.

There was discussion regarding a grant received by Santa Fe County for EV chargers and the repair and maintenance of the chargers.
