# A. REVIEW AND RECOMMEND 2025-2026 SANTA FE MPO UNIFIED PLANNING WORK PROGRAM (UPWP) ADOPTION VIA SELF-CERTIFICATION

Mr. Aune gave a Power Presentation on this item saying, this is a Federal obligation for a two year Federal budget. In this process, we identify two years of the Federal funds we anticipate and the tasks as to what we will be doing and where the funding will go.

Mr. Aune reviewed the categories and substantive changes.

Everyone introduced themselves.

Commissioner Hughes asked how much this document changes version to version.

Mr. Aune said we have pretty smooth transitions. We have to include any new Federal legislation that has been passed and reflect changes in the language.

Chair Hughes stated that we all look to the MPO to be the experts for all things road and transportation.

Councilor Castro asked if there were specific projects she needs to wrap her head around and about consultant fees.

Mr. Aune said we have had a continuing relationship with our consultant for many years. He helps us with a variety of things including large projects and some smaller projects.

Commissioner Greene said when he spoke about projects that are coordinated between the City, County and others with funding divided between the entities, he was

thinking of about a dozen projects. The projects he had in mind are to be funded through Federal funds, City and County funds, grants, flat grants, outdoor recreation funding and other funding opportunities. We need to be lining our projects up so they are ready when funding opportunities come up.

**MOTION** A motion was made by Commissioner Hansen, seconded by Councilor Faulkner, to recommend approval of the 2025-2026 Santa Fe MPO Unified Planning Work Program.

**VOTE** The motion passed on a voice vote.

us. The funding cycle ends at the end of August. We need to put a plan together.
