B. Release for public review: DRAFT 2025-2050 Santa Fe Metropolitan Transportation Plan:

- Erick: Presented two-year effort to update MTP, required by Federal regulation every 5 years
- Leah: Outlined 8 chapters including background, demographics, transportation system
- Project list totals approximately \$700 million, with \$380 million estimated available funding
- 32-day public review period starting Friday
- Two public meetings scheduled: July 22nd (virtual) and July 24th (in-person)
- Final adoption planned for August

MOTION: A motion was made by Jacqueline Beam_, seconded by Andrew Baca, to release for public review the DRAFT 2025-2050 Santa Fe MTP.

MPO Staff provided a brief background as to the development of the draft, where to find it for review and detailed elements of the draft plan.

C. Release for public review: DRAFT 2025 Public Participation Plan
