A. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

PRESENTATION - ARCHITECTURAL/ARTISTIC STANDARDS BRIDGES AND INFRASTRUCTURE

Ms. Bell and Ms. Neldim gave a PowerPoint presentation including the project scope, time line, deliverables, how communities can participate and how the project connects with communities.

B. PRESENTATION - TRANSPORTATION PROJECT FUND - NMDOT

Ms. Gilette gave a PowerPoint presentation, including the history of the fund, the process, the call for projects and the deadline of May 31st.

C. UPDATE ON MTP UPDATE - PUBLIC ENGAGEMENT AND TECHNICAL UPDATES

Ms. Yngve presented the update on the MPO summary of public engagement they received, story maps and project evaluation public review periods in July.

D. PROJECT UPDATES

Mr. Clavio said the County is in the process of letting a few transportation projects out. We got several appropriations from the Legislature last year. We are working on the Madrid walk project to create a safe walk path, bike lanes in the Las Companas area, integrating safety improvements at Camino La Tierra, evaluating secondary emergency egress in the Santa Fe foothills area, and a road safety project in

La Cienega. The Transportation Research Board is going to have a conference in June in Albuquerque. He encouages attendance if you have an opportunity.

Ms. Morrow said we are working on removing a traffic signal at Sandoval and Montezuma. It is before the City Council now. We are working on a quote. We are trying to find a location for a bike light.

Ms. Wolfenbarger said we have continued pavement improvement projects throughout the City. We are looking for opportunities to widen bicycle facilities, a possible high visibility crosswalk and traffic calming. We are also working on the engineering standards and are focused on transportation and drainage at this time.

Chair Gibson said we are excited to announce that we are bringing back routes that were suspended, including the routes for Tesuque, Santa Fe to Espanola, and San Ildefonso, to connect with other regional routes. We are nearing a ribbon cutting on our Taos Operations Facility as well.

Ms. Nino said we are working internally on proposals that have come in for GIF. We will ask for submittals for PFs.

Mr. Alvarado said we did kick off our General Plan project. It is now in full swing. We are getting together engagement partners. It will have some transportation implications down the road. It is a two year project.

Ms. Yngve said Hannah has moved on to get back to environmental science. Hopefully we will find a replacement within the year.
